he management team at Heritage Bank & Trust would like to provide you, as shareholders, with an update of your Bank.

The

to see loan
and deposit

growth over the last twelve months. Loans have grown 13 percent, which equates to \$128 million in gross loans. Deposits have grown 23 percent, which equates to \$155 million in deposits. As of March 31, 2019, the total asset size of the Bank was \$171 million.

Although 2019's first quarter earnings outpaced the prior year by almost 10 percent, Return on Assets was down slightly to 0.79 percent for 2019, as compared to 0.84 percent for 2018 — due to the strong growth of the Bank over the last 12 months. (This is normal in the banking industry, in which the income statement follows the balance sheet). Speaking of the balance sheet, asset quality remains

very high as we continue to strive to maintain credit discipline and diversity.

"Making Your Life Better." That's the marketing messaging that our Bank will be focusing on for the next year. From providing convenient locations across southern Middle Tennessee to revamping our

> website with the ability to open an account online, we are striving to make your life better every day whether it be loan customers, deposit customers, shareholders or all of the above.


















## Heritage Bank & Trust Honors Maury & Lawrence County Coloring Contest Winners
